

## CAMPING

- The reservation becomes effective after the advance payment 110 € (91 € as an advance payment which will be deducted + 19 € for reservation charge), after you have received our letter confirming the reservation.
- The reservation is strictly personal and cannot be transferred to others.
- The amount of the stay will be payed on the arrival date and no reimbursement will be agreed in case of late arrival or early departure.
- Arrival after 12 am, Departure before 12 am.
- In case of change of reservation dates you are requested to inform the Director in writing. Otherwise the place becomes available for other persons the next day at 12 am and the advance payment remains with the Director.
- In case of cancelling in writing before 30th of April, the advance payment will be refunded. After this date there will be no refund, except if you have insured yourself against cancellation.
- Insurance policy: the client has to take out an insurance policy for his caravan and his tent and also for his civil liability.
- Cancellation insurance: 11 €

## LOCATION

- This rental agreement comes into effect when I receive an advance payment of 30% of the cost of the stay + reservation charge, after you have received our letter confirming the reservation.
  - The reservation is strictly personal and cannot be transferred.
  - The amount of the stay will be payed on the arrival date and no reimbursement will be agreed in case of late arrival or early departure.
  - Arrival after 15 pm, Departure before 10 am.
  - In case of the client wishes to change the arrival date he must inform the Director in writing, otherwise the rented mobil home will be available until the following day till 12 am and the total amount for the rental period will be due.
  - In case of cancellation, you will be charged or liable to pay:
    - Reservation cost
    - Indemnity and/or compensation cost of breach of contract:
      - A charge of the amount of 30% of the total rental cost in case of cancellation is done at least 30 days before the foreseen arrival date.
      - A charge equal to the total rental cost in case of cancellation less than 31 days before the foreseen arrival date, or in case you have not presented yourself at this day.
  - A cancellation insurance is included in your rental agreement. This insurance will reimburse to you the indemnity or compensation cost resulting from breach of contract as foreseen in this contract agreement.
- Cancellation insurance of 15 €/week

## DEPOSIT

For accommodation rental, a security deposit of 200€ will be requested on arrival. Final cleaning of mobil home is the customer's responsibility. The security deposit will be returned on departure if there is no damage, inventory is intact and the accommodation is left perfectly clean and tidy. A fixed amount of 60 € will be asked for if cleaning has not been thoroughly performed.

Deposit will also be requested for the barrier key: 20€

## ANIMALS

A vaccination book is obligatory. It must be up to date and include a certified valid vaccination for rabid virus. The vaccination book is to be handed over at the reception. Dogs of the 1<sup>st</sup> and 2<sup>nd</sup> category will not be accepted. There will be extra charges for all animals.

- The client confirms to be conversant with the general cost-tarifs and internal regulations of the camping, in particular: bermuda-shorts or swimming-shorts are formally unacceptable in the swimming-pool area and between 11pm and 7am total silence is required. The tenant undertakes to adhere to these instructions and shall respect them with all his family.
